Heading off to college in 2014?

TME Federal Credit Union is pleased to announce a college scholarship opportunity that may make it easier for you to meet tuition costs. TME will award two \$500 scholarships to our college bound credit union members to be given away in 2014. To be eligible, applicants must meet the following requirements:

Eligibility:

Applicant Must:

- Be a member of TME Federal Credit Union for at least three months prior to the time of application.
- Be the primary member of their account and applicant's account must be in good standing.
- Be enrolled, on a full time basis, in a two or four year regionally accredited college/university.
- Have a minimum GPA (grade point average) of 3.0 on a 4.0 scale and/or the equivalent to a higher scale.
- Persons awarded the scholarship agree to have their name/photos published as deemed appropriate by the credit union.

Instructions:

- Complete the application and submit it to the address listed below. All applications must be received by **February 7, 2014**. Applications received after February 7 will not be considered.
- Completed applications must include grade transcripts indicating applicants' accumulative GPA.
- Applications must include a minimum of one (1) letter of recommendation written by an individual who is knowledgeable of the applicant's academic studies and is not a member of the applicants' immediate family.
- Complete an essay of not less than 250 but not more than 300 words explaining the applicants' future goals.

- The Deadline is February 7, 2014. All applicants will receive a letter from the credit union regarding the outcome of their application.
- Make a copy of the completed application packet for your records.

Payment:

- Scholarship Awards will be announced at our annual meeting in March 2014. Each award will be paid directly to the school, credited in the recipients' name.

All applications become the property of TME Federal Credit Union upon receipt and will be destroyed following the application review and selection process.

The decision will be made by an independent selection committee. All decisions are final.

DORMANT ACCOUNT CHANGE

Effective January 1, 2014, there will be a change to our dormant account policy.

The new policy reflects that if there is no activity in the account after one (1) year, a fee of \$1.00 per month will be assessed to the savings account until a deposit or withdrawal is made in the inactive account.
